Product Description

Interleukin-1 receptor-associated kinase 4 (IRAK4) is an important mediator in the signal transduction of Toll-like receptor (TLR) and IL1R family members.¹ IRAK4 is involved in the Toll-like receptor signaling pathway leading to apoptosis. IRAK4 has molecular functions such as protein binding, ATP binding, kinase activity, and Mg²⁺ binding. Toll/IL-1 receptor family members like IRAK4 are central components of host defense mechanisms in a variety of species.² One well conserved element in their signal transduction is the Ser/Thr kinase activity which couples early signaling events in a receptor complex at the plasma membrane to larger signalosomes in the cytosol.

This recombinant product was expressed by baculovirus in *Sf*9 insect cells using an N-terminal GST-tag. The gene accession number is BC013316. It is supplied in 50 mM Tris-HCI, pH 7.5, with 150 mM NaCI, 0.25 mM DTT, 0.1 mM EGTA, 0.1 mM EDTA, 0.1 mM PMSF, and 25% glycerol.

Procedure

Preparation Instructions

Kinase Assay Buffer – 25 mM MOPS, pH 7.2, 12.5 mM glycerol 2-phosphate, 25 mM MgCl₂, 5 mM EGTA, and 2 mM EDTA. Just prior to use, add DTT to a final concentration of 0.25 mM.

Kinase Dilution Buffer – Dilute the Kinase Assay Buffer 5-fold with water.

Kinase Solution – Dilute the active IRAK4 ($0.1 \ \mu g/\mu l$) with Kinase Dilution Buffer to the desired concentration. <u>Note</u>: The lot-specific specific activity plot may be used as a guideline (see Figure 2). It is recommended the researcher perform a serial dilution of active IRAK4 kinase for optimal results.

10 mM ATP Stock Solution – Dissolve 55 mg of ATP in 10 ml of Kinase Assay Buffer. Store in 200 μ l aliquots at –20 °C.

 γ -³²P-ATP Assay Cocktail (250 μ M) – Combine 5.75 ml of Kinase Assay Buffer, 150 μ l of 10 mM ATP Stock Solution, 100 μ l of γ -³²P-ATP (1 mCi/100 μ l). Store in 1 ml aliquots at –20 °C.

Substrate Solution – Dissolve the myelin basic protein (MBP) in water at a final concentration of 1 mg/ml.

1% phosphoric acid solution – Dilute 10 ml of concentrated phosphoric acid to a final volume of 1 L with water.

<u>Kinase Assay</u>

This assay involves the use of the ³²P radioisotope. All institutional guidelines regarding the use of radioisotopes should be followed.

- 1. Thaw the active IRAK4, Kinase Assay Buffer, Substrate Solution, and Kinase Dilution Buffer on ice. The γ -³²P-ATP Assay Cocktail may be thawed at room temperature.
- In a pre-cooled microcentrifuge tube, add the following solutions to a volume of 20 μl: 10 μl of Kinase Solution 5 μl of Substrate Solution 5 μl of cold water (4 °C)
- 3. Set up a blank control as outlined in step 2, substituting 5 μ l of cold water (4 °C) for the
- Substrate Solution.
 Initiate each reaction with the addition of 5 μl of the γ-³²P-ATP Assay Cocktail, bringing the final reaction volume to 25 μl. Incubate the mixture in a water bath at 30 °C for 15 minutes.
- 5. After the 15 minute incubation, stop the reaction by spotting 20 μ l of the reaction mixture onto an individually precut strip of phosphocellulose P81 paper.

- 6. Air dry the precut P81 strip and sequentially wash in the 1% phosphoric acid solution with constant gentle stirring. It is recommended the strips be washed a total of 3 times of ~10 minutes each.
- 7. Set up a radioactive control to measure the total γ^{-32} P-ATP counts introduced into the reaction. Spot 5 µl of the γ^{-32} P-ATP Assay Cocktail on a precut P81 strip. Dry the sample for 2 minutes and read the counts. Do not wash this sample.
- 8. Count the radioactivity on the P81 paper in the presence of scintillation fluid in a scintillation counter.
- 9. Determine the corrected cpm by subtracting the blank control value (see step 3) from each sample and calculate the kinase specific activity

Calculations:

1. Specific Radioactivity (SR) of ATP (cpm/nmole)

SR = $cpm of 5 \mu l of \gamma^{-32}P-ATP Assay Cocktail nmole of ATP$

cpm – value from control (step 7) nmole – 1.25 nmole (5 μl of 250 μM ATP Assay Cocktail)

2. Specific Kinase Activity (SA) (nmole/min/mg)

nmole/min/mg =
$$\frac{\Delta \text{cpm} \times (25/20)}{\text{SR} \times \text{E} \times \text{T}}$$

SR = specific radioactivity of the ATP (cpm/nmole ATP) \triangle cpm = cpm of the sample – cpm of the blank (step 3) 25 = total reaction volume

20 = spot volume

T = reaction time (minutes)

E = amount of enzyme (mg)
